PRE-QUALIFICATION

Only bidders who meet the following criteria will be will qualify to be evaluated:

- Accordingly, only the bidders with a B-BBEE status level 4 or lower (3,2,1) or an EME or QSE
- **Mandatory Administrative Requirements-** as listed in the tender document.

EVALUATION

Tenderer must score minimum score per each sub section and an overall minimum threshold of 80 points out of 100 is required to be achieved for the tender to be eligible for further evaluation on Price and B-BBEE (80/20 split).

Bids will be evaluated in terms of the 80/20 Preference point

system as per the Preferential Procurement Policy Framework Act, Regulations 2017.
