Accordingly, only bidders with a Level 1 or 2 BBBE contributor level will be considered to go through to the next stage of the evaluation. Bidder must submit a valid certified copy or original BBEE certificate issued by a SANAS approved verification agency, EME and QSE may submit a sworn affidavit. ACSA reserves the right to request further information necessary to evaluate the bidder in this regard.

EVALUATION

Bids will be evaluated in terms of the 90/10 or 80/20 Preference point system as per the Preferential Procurement Policy Framework Act, Regulations 2017.
