- Mandatory Administrative Requirements- as listed in the tender document clause 7

## EVALUATION

Functionality Evaluation criteria- bidders must meet per criterion 60 points out of 100 to be eligible for further evaluation on Price and BBEE as listed on the bid document.

Bids will be evaluated in terms of the 80/20 Preference point system as per the Preferential Procurement Policy Framework Act, Regulations 2017.
