EVALUATION

Functionality Evaluation criteria- bidders must meet overall points of 60 out of 100 to be eligible for further evaluation on Price and BBBEE as listed on Section 5 clause 5.5

Bids will be evaluated in terms of the 80/20 Preference point system as per the Preferential Procurement Policy Framework Act, Regulations 2017.
