PRE-QUALIFICATION

Only bidders who meet the following criteria will be will qualify to be evaluated:

To advance designated groups in line with the Preferential Procurement Regulations of 2017, all tenderers must comply with the following:

- 1] The Tenderer must have a **B-BBEE Level 1, 2,** or
- 2] Tenderers that do not meet the above shall allocate 30% of the contract value towards the advancement of QSE's or EME's that meet the following criteria. Prior to appointment of the successful tenderer verification of the chosen QSE's or EME's will be conducted.

- an EME or QSE which is at least 51% owned by black people;
- an EME or QSE which is at least 51% owned by black people who are youth;
- an EME or QSE which is at least 51% owned by black people who are women;
- an EME or QSE which is at least 51% owned by black people with disabilities;

- an EME or QSE which is 51% owned by black people living in rural or underdeveloped areas or townships;
- a cooperative which is at least 51% owned by black people;
- an EME or QSE which is at least 51% owned by black people who are military veterans;

EVALUATION

Bids will be evaluated in terms of the 80/20 Preference point system as per the Preferential Procurement Policy Framework Act, Regulations 2017.
