## MANDATORY REQUIREMENTS

**Only bidders who meet the following criteria will qualify to be evaluated:**

1. Attendance to Compulsory Site Meeting.
2. Warranty: Bidder to provide a letter confirming a minimum of 2 years warranty for the units to be designed, supplied, delivered and installed.

## TECHNICAL/FUNCTIONALITY EVALUATION

Bidders must meet the minimum threshold points per criterion and a minimum of **65** out of 100 points to be considered further evaluation.

## PRICE AND B-BBEE

The final stage of the evaluation process will be price and b-bbee and bids will be evaluated in terms of the 80/20 Preference point system as the Preferential Procurement

Policy Framework Act, Regulations 2017.
