# **SECTION 2: EVALUATION CRITERIA**

#### 2.1 Evaluation Criteria

- 2.1.1 ACSA will use a pre-determined evaluation criteria when considering received bids. The evaluation criteria will consider *mandatory requirements, functionality and technical aspects, Price and Preference*. During the evaluation of received bids ACSA will make an assessment whether all the bids comply with set minimum requirements and whether all returnable documents/information have been submitted. Bidders which fail to meet minimum requirements, thresholds or have not submitted required mandatory documents will be disqualified from the bid process.
- 2.1.2 The requirements of any given stage must be complied with prior to progression to the next stage. ACSA reserves the right to give bidders reasonable time to submit information that will be required in Stage 1 below.
- 2.2 A staged approach will be used to evaluate bids and the approach will be as follows:

# 2.2.1 Stage 1: Mandatory Requirements

- I. Completed in full and signed Form of Offer C1.1 (See NEC3 TSC).
- II. Attendance of a Virtual/Online Compulsory Briefing Session.
- III. Bidders must submit a valid Letter of Good standing issued by the Department of Labour workman's compensation commissioner (COIDA), or the Federated Employer's Mutual Assurance Company (FEM) or Rand Mutual Assurance (RMA).
- IV. Bidders must accept ACSA's Terms and Conditions (Part of Form of Offer on NEC 3 TSC).

# 2.2.2 Stage 2 Functionality

In determining the bidders capacity and capability to execute the contract/project, bidders will be evaluated on functionality. Functionality is the terminology used to define the technical ability of the Tenderer, based on experience to deliver the required product in accordance with the specialised quality, reliability and functionality.

Points allocated for Functionality shall be evaluated in accordance with the criteria as listed below. An overall minimum threshold of **90** points out of **100** must be achieved for the tender to be eligible for further evaluation on Price and Preference **80/20** split. Bidders who also fail to achieve the minimum score per criteria will be disqualified and not be eligible for further evaluations.

# 3.3.1 Description of the service

#### 3.3.1.1 Executive overview

The purpose of this initiative is to appoint a supplier to provide human capital for the operation of ACSA's Baggage Handling System at Cape Town International Airport over a five-year period. The Baggage Handling System comprises the Bag Stage (SAC) operating system, Supervisory Control and Data Acquisition (SCADA), conveyor-driven machinery (including conveyor belts), chutes, and carousel units.

# 3.3.1.2 Criticality of Commodity

This initiative is of critical importance to ACSA, as any failure to ensure the effective operation of the Baggage Handling System (BHS) could lead to the loss of customer baggage and flight delays. Additionally, improper system operation may disrupt Ground Handling activities, delay the delivery of passenger baggage, and impact the timely departure of scheduled flights.

# 3.3.1.3 Complexity of Commodity

The operational service of the Baggage Handling System (BHS) is highly complex and requires qualified personnel with expertise in automated systems and SCADA. All operations must be carried out in compliance with the Occupational Health and Safety Act, the Driven Machinery Regulations, and relevant Engineering Standards. The Contractor will be responsible for providing personnel who are appropriately skilled and qualified to effectively perform these duties throughout the operational period

The Contractor shall ensure compliance to general safety regulations and standards such as

- OHS Act Administration regulations of 2003,
- General Health & Safety Regulations of 2005,
- Electrical installation Regulation of 2009,
- General Machinery Regulation,
- Driven Machinery Regulations and
- Applicable Engineering Standards.

All work shall be charged according to the BID Pricing Schedule. However, no labour cost will be paid for any non-scheduled work, or flight delays carried out by a scheduled operation shift.

Upon completion of each shift, the Contractor shall prepare and submit a comprehensive written logbook service report for the Baggage Handling System. This report must detail all activities undertaken, any additional work performed and be submitted to the Employer's representative. The report format (pro forma) shall be subject to the Employer's approval. In addition, detailed operational logbook sheets must be completed and submitted to the Employer after each operational shift or service activity.

The Contractor will be responsible for providing all resources that will be required for the execution of the works as per the scope, on site to comply with the Response Time requirements of this contract.

The Contractor shall ensure that all building areas in proximity to conveyors, carousels, and chutes as well as building areas mostly dedicated to the Baggage Sortation System are maintained in a broom-swept state.

The Contractor shall ensure that, unless a special arrangement is made with the Service Manager, all senior staff members and on-site support staff are always immediately reachable via cell phone.

The Contractor shall ensure that all Operational staff are issued with uniforms that will comply with a minimum requirement as agreed with the Service Manager from time to time. Current airport requirements are safety shoes, correct PPE and a uniquely numbered reflective jacket (for easy identification via CCTV).

Furthermore, the contractor will be expected to be present for essential power simulation and testing during predetermined intervals that will be communicated to the contractor. It should be noted that ACSA will not compensate the service provider for being present for Essential Power Simulations.

# 3.3.1.4 Employer's requirements for the service

- I. To start, stop and control the system through Bag stage (SAC)/SCADA/ MIS/ MCP
- II. To monitor and ensure that baggage trays are tipping within OEM specified time
- III. To monitor and correct overhanging baggage on trays
- IV. Keep a watch for anybody opening and/or stealing from luggage and report it to the security control room,
- V. To implement physical baggage handling in the event of system failures or execution of fall-back plan
- VI. Identify faults and report to the baggage technician/service manager for rectification
- VII. To reset all alarm faults on the SCADA system and ensure communications are relayed to the technical artisan if faults keep recurring
- VIII. To provide daily, weekly and monthly operation and technical report to the client for all the systems
  - IX. To monitor authorized repair work and record it on the log sheet/ occurrence book
  - X. The service provider shall maintain a record of the services or repairs carried out on the machinery as have it available for the Service Manager as and when required
- XI. The supervisory staff should be specifically trained and have extensive experience in the operation of the Baggage Handling System as defined in the scope of works

- XII. All safety-related provisions and guidelines that are required by law or that were imparted during routine training interventions must be adhered to. The service provider personnel must comply with the regulations of the OHS Act Administration regulations of 2003, General Health and Safety Regulations of 2005, Electrical Installation Regulations of 2009, General Machinery Regulation, Driven Machinery Regulations and applicable Engineering Standards including IATA resolutions
- XIII. Breakdowns may not be left unreported for the next day or shift.
- XIV. For each piece of equipment, all work will be carried out to standards as required by the Original Equipment Manufacturer (OEM) as well as any applicable governing law and/or regulations. Where OEM standards differ from those required by this document the more stringent requirement shall apply.
- XV. The Contractor will be fully responsible for obtaining (and keeping up to date with) said requirements including **International Air Transport Association(**" IATA') resolutions.
- XVI. The Contractor shall always remain responsible for ensuring that the on-site staff compliment and operation regime is sufficient to maintain the service levels and system performance indicators as stipulated in the contract section 7.
- XVII. The Contractor shall always comply with the Minimum Staffing Schedule: viz;
  - a. Site Manager x1
  - b. Supervisor x 1
  - c. System Operators x 6
  - d. Semi-skilled Operators x 24
  - e. Cleaners x 3
- XVIII. This may be amended by mutual arrangement between ACSA and the Contractor from time to time.
- XIX. All work shall be charged according to the BID Pricing Schedule. However, no labour cost will be paid for any non-scheduled work, or flight delays carried out by a scheduled operation shift.
- XX. - 6.1 The receiving party shall not use any intellectual property of the Company (including trademarks, service marks, logos, slogans, trade names, brand names and other indicia of origin) (collectively, the "Company IP") for any reason whatsoever without first obtaining the Company's prior written consent which consent the Company shall be entitled to grant solely at its own discretion.

# 7. **DURATION**

- 12.4 The parties acknowledge that this agreement and the undertakings given by it in terms hereof are fair and reasonable in regard to their nature, extent and period and go no further than is reasonably necessary to protect the interests of the parties.
- 12.5 The parties hereby confirm that they have entered into this agreement with full and clear understanding of the nature, significance and effect thereof and freely and voluntarily and without duress.
- 12.6 Neither party shall have the right to assign or otherwise transfer any of its rights or obligations under this agreement.
- 12.7 This agreement may be executed in several counterparts that together shall constitute one and the same instrument.
- 12.8 In this agreement, clause headings are for convenience and shall not be used in its interpretation.
- 12.9 Each clause of this agreement is severable, the one from the other and if any one or more clauses are found to be invalid or unenforceable, that clause shall not affect the balance of the clauses which shall remain in full force and effect.

### 3. Application of the Law

When a body of persons forms a joint venture, partnership or consortium, such a body is treated as a separate legal person for VAT purposes and, is in terms of section 51(1) of the VAT Act ,required to register for VAT with the South African Revenue Services ("SARS")where the body's taxable supplies exceed the registration threshold.

Should the joint venture or partnership or consortium not be registered for VAT, **VAT cannot be levied on any invoice** that will be issued out to Airports Company South Africa for services rendered.
