- Bidder must provide Bidder's proof of proximity / footprint to ACSA's sites;
- Bidder's must be registered on the National Treasury Central Supplier Database (CSD, www.csd.gov.za);
- Bidder should submit a valid & original Tax Clearance certificate;
- Bidder should submit proof of relevant BBEE certificate; etc
