The bid closes on **Friday 06 November 2020 at 12:00 midday**. All bid documents must be provided in duplicate (printed) format and electronic copy using a compact disc or flash drive, sealed in a clearly marked envelope / package marked with **Bidder's name, return address and Bid Description**. **Replicated documents may only be accepted as responsive if all the information is identical**

to the original bid document.

Pre-Qualification Criteria

- Only bids from bidders with a minimum **B-BBEE status level 1 and 2** will be considered.

Mandatory Criteria

Bidders that do not meet any one of the following mandatory criteria will be disqualified and will not be evaluated further:

- Bidders acceptance of terms and conditions of bid.
- Bidders must submit the Central Supplier Database Report.

EVALUATION

The functional/technical evaluation will be based on a threshold, where bidders which fail to achieve a minimum of 55 points out of a total of 100 points on the functional/technical stage will not be considered further in the evaluation. It should be further noted that a minimum qualifying score per criteria must be met.

Bids will be evaluated in terms of the 80/20 Preference point system as per the Preferential Procurement Policy Framework Act, Regulations 2017.
