Pre-Qualification Criteria

- Only bids from bidders with a minimum **B-BBEE status level 1,2 and 3** will be considered.
- All Bidders must subcontract a minimum of 30% to any of the Designated Group (s) as set out in the PPPFA Regulation 4:
 - i. an EME or QSE which is at least 51% owned by black people;
 - ii. an EME or QSE which is at least 51% owned by black people who are youth;
 - iii. an EME or QSE which is at least 51% owned by black people who are women;
 - iv. an EME or QSE which is at least 51% owned by black people with disabilities;

Mandatory Criteria

Bidders that do not meet any one of the following mandatory criteria will be disqualified and will not be evaluated further:

- Bidders acceptance of terms and conditions of bid.
- Only bids from bidders who are one hundred percent (100%) locally manufactured or have directives or are in possession of a directive from the DTI will be considered. (Must submit all documentation as directed by SBD6.2, this includes the covering directive letter from the DTI, and the completed SATS 1286 and all its relevant annexures).
- Bidders are advised that all prices must be quoted in South African Rand (ZAR). The price proposal must

- be completed in full.
- Bidders must submit the Central Supplier Database Report.
- Bidders must submit their Registration and Compliance Certificates with the National Bargaining Council (NBC) – this must include their level within the National Bargaining Council.

EVALUATION

Bids will be evaluated in terms of the 90/10 Preference point system as per the Preferential Procurement Policy Framework Act, Regulations 2017.

DISCLAIMERS

Failure to provide proof of B-BBEE status will result in a B-BBEE scoring of 0.

No tender will be awarded to any bidder:

3. Who has directors employed by the State;
4. Who is Blacklisted by National Treasury; and
